

Daily Report 30/2021


8 February 2021¹

Summary

- Between the evenings of 5 and 7 February, the Mission recorded 349 ceasefire violations in Donetsk region. In the previous reporting period, it recorded eight ceasefire violations in the region.
- Between the evenings of 5 and 7 February, the SMM recorded 25 ceasefire violations in Luhansk region. In the previous reporting period, it recorded two ceasefire violations in the region.
- Small-arms fire was assessed as directed at an SMM mini-unmanned aerial vehicle close to the railway station in Donetsk city.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. The Mission again saw containers inside and near the southern edge of the area near Zolote and recorded three shots of small-arms fire inside the area near Petrivske.
- The SMM facilitated and monitored adherence to localized ceasefires to enable operation and maintenance of critical civilian infrastructure and demining activities. It recorded ceasefire violations near the Donetsk Filtration Station (DFS), near the time when a bus with DFS workers was driving to the station.
- The Mission continued following up on the situation of civilians, including at four entryexit checkpoints and four corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The SMM visited two border crossing points outside government-control and monitored border areas in Donetsk region.
- The Mission's freedom of movement continued to be restricted, including at checkpoints
 of the armed formations near Vasylivka, Nova Marivka, Shevchenko, Prymorske,
 Khreshchatytske (formerly Krasnoarmiiske) and Zaichenko, all in southern Donetsk
 region.*

Ceasefire violations²



In Donetsk region, between the evenings of 5 and 7 February, the SMM recorded 349 ceasefire violations, including 184 undetermined explosions, the majority of which were recorded in areas near the Donetsk Filtration Station (DFS) (15km north of Donetsk) (see below), and at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk) (including 69 undetermined explosions). In the <u>previous reporting period</u>, the Mission recorded eight ceasefire violations.

In Luhansk region, between the evenings of 5 and 7 February, the Mission recorded 25 ceasefire violations, including eight undetermined explosions, the majority of ceasefire which were recorded in areas east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below). In the <u>previous reporting period</u>, the SMM recorded two ceasefire violations in the region.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding additional measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has so far recorded at least 8,461 ceasefire violations in both Donetsk and Luhansk regions (including 3,179 explosions, 1,074 projectiles in flight, 101 muzzle flashes, 60 illumination flares and at least 4,047 bursts and shots).

Small-arms fire assessed as directed at SMM mini-unmanned aerial vehicle close to the railway station in Donetsk city

On 6 February, while positioned about 3km west-south-west of the railway station in Donetsk city (non-government-controlled, 6km north-west of Donetsk city centre) at about 11:02 to conduct an announced mini-unmanned aerial vehicle (UAV) flight, the SMM heard two bursts of small-arms fire at an assessed range of 0.7-1km north-west. Three minutes later, it heard three bursts of small-arms fire at an assessed range 300-400m north-west. All of these bursts were assessed as aimed at the UAV, which was flying about 0.7-1km and 300-400m north-west of the SMM's position. The Mission landed the UAV and left the area.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 6 and 7 February, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw members of the armed formations (wearing armbands with "JCCC" written on them) on the southern edge of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

During the day on 6 and 7 February, while positioned at three locations near the **disengagement area near Zolote**, the Mission heard two undetermined explosions and four bursts of undetermined weapons. On the night between 6 and 7 February, the SMM camera in Zolote recorded 13 projectiles in flight and an undetermined explosion, at an assessed range of 1-3km east. All these ceasefire violations were assessed as outside the area, but within 5km of its periphery.

On both days, while positioned near the checkpoint of the armed formations south of the area, the SMM saw six containers on the southern edge of the road leading eastward towards Zolote-5/Mykhailivka (non-government-controlled, 61km west of Luhansk), of which five were inside

a fenced perimeter south of the area's southern edge (for previous observations in the area, see <u>SMM Daily Report of 6 February 2021</u>).

On 6 February, inside the disengagement area, about 350m north of its southern edge, the SMM again saw a container on the western edge of road T-1316.

On 6 and 7 February, while positioned near the checkpoint of the armed formations south of the area, the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them). On the latter day, it saw some of them walk inside the area to about 350m north of its southern edge, accompanied by people in protective medical gear, and then return.

On 6 February, while positioned about 1.7km east-north-east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM heard three shots of small-arms fire at an assessed distance of 2km east, assessed as inside the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk), as well as five undetermined explosions at an assessed range of 5-10km south-east and south, and eight shots of small-arms fire at an assessed distance of 2km south and west, all assessed as outside the area but within 5km of its periphery.

On 7 February, while positioned at the same location, the Mission recorded an undetermined explosion at an assessed range of 5-8km south-south-east, assessed as outside the area but within 5km of its periphery.

Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

Indications of military and military-type presence in the security zone⁶

The Mission observed armoured combat vehicles and a command vehicle in compounds in non-government-controlled areas of Luhansk region (for further information, see the table below).

On 6 February, about 1.6km north-north-west of Lebedynske (government-controlled, 99km south of Donetsk), the Mission observed a stationary minivan with an antenna next to it and a white non-SMM mid-range UAV laying on the ground beside the vehicle (for previous observations in the area see SMM Daily Report 1 February 2021).

Mine hazard signs in Nova Marivka, Tavrycheske and Kreshchatytske, Donetsk region, and Presence of aanti-personnel mine near Molodizhne, Luhansk region

On 6 February, about 2km south-east-south of Nova Marivka (non-government-controlled, 64km south of Donetsk), the Mission saw for the first time at least four mine hazard signs (black skull and crossbones with "Mines. Caution" written on them in Cyrillic), in a field adjacent to an unpaved road. About 1.5km east-north-east of Tavrycheske (non-government-controlled, 76km south of Donetsk), on the northern side of road C-051610, the SMM observed for the first time at least three mine hazard signs (white skull and crossbones with "Danger!

Mines" written on them in Cyrillic). About 1km west of Khreshchatytske (formerly Krasnoarmiiske, non-government-controlled, 86km south of Donetsk), the Mission observed for the first time six mine hazard signs (white skull and crossbones with "Danger! Mines" written on them in Cyrillic) on both sides of a road, near a checkpoint of the armed formations.

On 7 February, about 2.5km south-west of Molodizhne (non-government-controlled, 63km north-west of Luhansk), the SMM <u>again</u> saw an anti-personnel mine (MON-200), assessed as belonging to the armed formations, in a field about 10m north of road T-0504.

SMM facilitation of operation, inspection and repairs to of critical civilian infrastructure and of demining

On 6 and 7 February, the Mission continued to facilitate the operation of the DFS. On 6 February, while positioned at two locations near the station, the SMM recorded 52 ceasefire violations (including 40 undetermined explosions), assessed as within a 5km radius of the station. All these ceasefire violations occurred near the time when a bus with DFS workers was driving on road M-04 towards the station. On 7 February, while positioned about 2.5km southeast of Avdiivka (government-controlled, 17km north of Donetsk), the Mission recorded 37 shots of small-arms fire, assessed as within a 5km radius of the DFS.

On 6 February, the Mission also facilitated and monitored adherence to localized ceasefires to enable maintenance and repairs of a power line in Holubivske (non-government-controlled, 51km west of Luhansk). While positioned in the settlement, the Mission heard five undetermined explosions at an assessed range of 2-5km north-west of its position.

On the same day, the SMM facilitated and monitored adherence to localized ceasefires to enable demining activities in agricultural fields near government-controlled Hirske (63km west of Luhansk) and Myrna Dolyna (67km north-west of Luhansk).

Situation at entry-exit checkpoints and corresponding checkpoints

In Donetsk region, on 6 February, the Mission saw that the entry-exit checkpoint (EECP) near Marinka (government-controlled, 23km south-west of Donetsk) was operational but did not observe any civilian traffic. It also noted that the corresponding checkpoint of the armed formations near Kreminets (non-government-controlled, 16km south-west of Donetsk) was closed.

In Luhansk region, on 6 and 7 February, the Mission noted that the EECP near Stanytsia Luhanska was operational and saw people passing through it in both directions. On 7 February, the SMM noted that the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge was operational and saw people passing through it in both directions.

On both days, the SMM noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were operational but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were not.

Border areas outside government control

On 6 February, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about two hours, the Mission observed 33 cars (including 13 with "DPR" plates), four covered cargo trucks (with "DPR" plates), a bus (with "DPR" plates and about 30 passengers (mixed genders and ages) and 27 pedestrians (12 women and 13 men, mixed ages and two boys) entering Ukraine. During the same time, the SMM saw 44 cars (including 27 with "DPR" plates), 14 covered cargo trucks (including eight with "DPR" plates), two buses (with "DPR" plates and about 50 passengers, mixed genders and ages, including 25 children) and 40 pedestrians (16 women and 21 men, mixed ages and three children) exiting Ukraine.

On the same day, while at a border crossing point near Ulianivske (61km south-east of Donetsk), for about 20 minutes, the Mission noted that it was operational, but did not observe any civilian traffic.

On the same day, the SMM monitored border areas near Stepne (72km east of Donetsk), Petropavlivka (68km south-east of Donetsk), Vasylivka (65km south-east of Donetsk), Novoivanivka (57km south-east of Donetsk), Kumachove (55km south-east of Donetsk), Pobeda (57km south-east of Donetsk), Hlynka (60km south-east of Donetsk), Kuznetsovo-Mykhailivka (67km south-east of Donetsk) and Zori (76km south-east of Donetsk) and observed a calm situation.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 2 February 2021). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denials:

On 6 February:

- At a checkpoint of the armed formations near Vasylivka (non-government-controlled, 47km south of Donetsk), two members of the armed formations (one visibly armed) denied the Mission passage towards Starolaspa (non-government-controlled, 51km south of Donetsk) citing "ongoing demining activities in the area". While at the checkpoint, the SMM observed one car passing through the checkpoint.

- At a checkpoint of the armed formations near Nova Marivka (non-governmentcontrolled, 64km south of Donetsk), two visibly armed members of the armed formations denied the SMM passage citing "an order from superiors".
- At another checkpoint of the armed formations near Nova Marivka, a visibly armed member of the armed formations denied the Mission passage towards Hryhorivka (nongovernment-controlled, 68km south of Donetsk) citing "the SMM's safety". While at the checkpoint, the Mission observed civilian traffic passing through.
- At a checkpoint of the armed formations near Shevchenko (non-government-controlled, 69km south of Donetsk), two visibly armed members of the armed formations denied Mission passage towards Hryhorivka citing "orders from superiors".
- At a checkpoint of the armed formations near Prymorske (non-government-controlled, 76km south of Donetsk), two visibly armed members of the armed formations denied Mission passage towards Naberezhne (non-government-controlled, 77km south of Donetsk) citing "demining activities in the area". While at the checkpoint, the Mission observed civilian traffic passing through.
- At a checkpoint of the armed formations near Khreshchatytske (formerly Krasnoarmiiske, non-government-controlled, 86km south of Donetsk), two visibly armed members of the armed formations denied the Mission passage towards Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk) citing "demining activities in the area".
- At a checkpoint of the armed formations near Zaichenko (non-government-controlled, 93km south of Donetsk), 11 members of the armed members (five of whom visibly armed) denied the Mission passage towards Pikuzy (formerly Kominternove, nongovernment-controlled, 92km south of Donetsk) citing "orders from superiors".

Regular restrictions related to disengagement areas and mines/UXO:

The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:⁷

- On 6 February, while positioned about 3km west-south-west of the railway station in Donetsk city (non-government-controlled, 6km north-west of Donetsk city centre) to conduct an announced mini-UAV flight, the SMM heard five bursts of small-arms fire, assessed as aimed at the UAV. The SMM landed the UAV and left the area (see above).
- The same SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over the south-western outskirts of Donetsk city.
- On the same day, SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, three times while flying over areas near the Kuibyshevskyi district of Donetsk city (non-government-controlled, 5km west of Donetsk city centre), twice near Vesele (non-government-controlled, 9km north-west of Donetsk) and once near Mineralne (non-government-controlled, 10km north-east of Donetsk).

- On 7 February, an SMM mini-UAV on two occasions experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Shyrokyne (government-controlled, 100km south of Donetsk).


