STATEMENT BY THE DELEGATION OF SERBIA

Mr. Chairperson, Excellencies, Ladies and gentlemen,

In the period from 18 to 22 February 2019, in accordance with the provisions of the Vienna Document 2011, a Finnish evaluation/inspection team, with a guest inspector from Hungary, conducted an evaluation visit to the 1st Army Brigade of the Serbian Armed Forces and made a specified area inspection in the Republic of Serbia.

On 5 March 2019, Finland provided all OSCE participating States with the CBM/FI/19/0014/F38/O format (Evaluation Visit Report) and the CBM/FI/19/0015/F35/O format (Specified Area Inspection Report), through the OSCE Communications Network.

In the said formats, Finland concluded that both activities were conducted in line with and in the spirit of Vienna Document 2011 and that all questions were properly answered and all ambiguities clarified. Furthermore, they praised the professional and cordial attitude of the escort team and the generous hospitality they received in the Republic of Serbia.

In particular, they expressed gratitude to the Republic of Serbia for the openness and transparency they experienced throughout the entire activity.

In both report formats, however, in spite of the above-mentioned positive assessment, when describing the tasks performed by the units of the Serbian Armed Forces, Finland used the expression, I quote, "border/boundary between Serbia and Kosovo".

In presentations given during the briefings in the units and in answers to questions raised, by contrast, speakers used the term "Administrative line towards the Autonomous Province of Kosovo and Metohija".

Kosovo and Metohija is an autonomous province of the Republic of Serbia, under the interim administration of the United Nations, subject to the legally binding UN Security Council resolution 1244 (1999).

It is absolutely unacceptable to misuse the above-mentioned OSCE notification formats in such a manner as to affirm the illegal, unilaterally declared independence of

so-called "Kosovo" while UN Security Council resolution 1244 (1999) is still in effect, guaranteeing the sovereignty and territorial integrity of the Republic of Serbia.

In addition, we would like to recall that the OSCE has proclaimed its position of neutrality with respect to the Autonomous Province of Kosovo and Metohija. Compliance with and implementation of the Vienna Document 2011 must be in line with UN Security Council resolution 1244 (1999), and the openness and transparency of the Republic of Serbia and the Vienna Document 2011 must not be misused.

STATEMENT BY THE DELEGATION OF FINLAND

Mr. Chairperson,

I would like to use my right of reply to respond to the statement by Serbia.

We have taken note of the objection by Serbia related to Finland's evaluation visit report and specified area inspection report.

I would like to inform you that the term used in the reports "border/boundary between Serbia and Kosovo" is status neutral-language, which is used in the EU-facilitated dialogue between Belgrade and Pristina – and is also accepted by Serbia.

I would also like to take this opportunity to thank our Serbian hosts for their excellent co-operation and professionalism during the evaluation visit, which was conducted in full accordance with the Vienna Document.

I would kindly ask the Chairperson to include this statement in the journal of the day.
