### 10.30 - 12.00 Session I: Public Service Broadcasting: values, content and strategic dilemmas. Perception of the Public Service Broadcasting in Central Asia

Transfer to the digital distribution of content and proliferation of online media outlets have diminished rather than strengthened public trust in the media. Yet, media coming up with unchecked and divisive information can still encourage violence and prompt strong reactions to events in public life. There is a need for a trusted medium, which carries news, public affairs and cultural programming, which is positively perceived by citizens and which encompasses all of the society rather than divides by region or language.

Against this background, the first session will offer deeper insights into the current dilemmas of the public service broadcasting, and its core values. It will explore what PSB means in terms of programming, ethical standards, and interaction with the audience. At the same time, the session will gauge the attitude to the public service broadcasting in the Central Asian participating States and Mongolia.
