Yes, Iceland ratified the Protocol on 22 August 2008.

4. What measures have been taken to prevent the indiscriminate use of mines, booby-traps and other devices?

The use of mines, booby-traps and similar devices is prohibited in Iceland. The mines that have been found in Iceland are mostly located at sea in Iceland and are mostly dated from World War II, as the waters around Iceland were extensively mined by both parties to the conflict. There are also explosive remnants on land from firing ranges and military exercise areas dating from World War II and onwards.

The Icelandic Coast Guard's explosive ordnance unit (EOD) locates and destroys hazardous explosives in Iceland. The Unit is trained and operates according to NATO standard and has extensive specialised knowledge and experience regarding bomb disposal.

5. Would your country be interested in receiving assistance related to the implementation of this Protocol? If so, please describe.

No, Iceland does not require such assistance.

6. Does your country have the capacity to assist others related to this Protocol? If so, please describe.

Iceland has participated in several demining operations in Iraq and Lebanon and is currently conducting EOD training for Ukraine. Iceland and Lithuania co-lead the Demining Coalition of Ukraine Defence Contact Group. Annual demining training exercises are held in Iceland under the auspices of NATO.

7. Has your country ratified or acceded to the 1997 Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction?

Yes, Iceland ratified the Convention on 5 May 1999.

The Althing passed an Implementation Act for the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction, No. 26 of 7 May 2001.

On 9 June 2023, the Althing passed an Act on disarmament, arms control and export control No. 68/2023 consolidating various legal acts implementing International Conventions on disarmament and arms control.

9. Does your country have any specific measures in place to provide assistance to victims?

Iceland has aided victims of landmines through various programs such as providing prosthetic, including in Bosnia, Iraq, and Ukraine.
