

CROSS-CUTTING REPORT FINDINGS



The Project's trial monitoring identified symptoms of systemic challenges at the institutional, legislative and policy level. However, initiatives are already underway to address many aspects of the issues identified in this Report. These include strategies, action plans, guidelines and targeted capacity building. These are substantial investments that, with sustained efforts, can lead to substantial progress.





The main areas identified for further improvement at the institutional level, to varying degrees across the region, relate to:



OWNERSHIP OF REFORM PROCESSES

- coordination of implementation of new guidelines, policy proposals and capacity-building efforts
- > oversight mechanisms for reform processes
- interinstitutional communication and collaboration



ACCOUNTABILITY & PERFORMANCE MANAGEMENT

- > type of performance assessment criteria (balance between quantitative and qualitative)
- incentives to implement standards that exist in policies and guidelines
- > structure and use of statistical data for evidence-informed decision making



RESOURCES ALLOCATION

- material and human resources
- specialized experts for financial investigations
- length of vacancies for judicial and prosecutorial appointments

TRACK RECORD

Create preconditions for an effective track record in combatting OCC.

IMPACT

Aim for changes that make an immediate difference.

BUY-IN

Address resistance to change, accounting for operational practices and working cultures.











EMBRACE DATA COLLECTION & ANALYSIS

to address all structural and systemic issues with evidence-informed policies.



STREAMLINE AND CONSOLIDATE

all guidelines, capacity building initiatives and strategies/action plans related to effective and efficient processing of OCC cases.



INCREASE ACCOUNTABILITY & OWNERSHIP

for the implementation of strategies, action plans and policies relating to OCC cases, by mandating the monitoring and evaluation of progress and the undertaking of corrective actions as well as comprehensive reporting.



CREATE INCENTIVE STRUCTURES

for the implementation of all tools available, from policies to subjectspecific guidelines, related to the effective and efficient processing of OCC cases.
