The opening session provides an opportunity for participating States and other Conference participants to identify common ground for how participating States can work together in practice to realize fully the vision of a comprehensive, co-operative and indivisible security community throughout the OSCE area. Following keynote addresses, the session will allow for an exchange of views on how the OSCE can use its existing instruments and toolbox to achieve the security community which was identified by OSCE Heads of State or Government in the 2010 Astana Commemorative Declaration: Towards a Security Community. The emphasis will be on practical action rather than on presenting new instruments, tools or proposals. This is to reflect the starting point that the most pressing issue is the absence of political will to use the existing tools that are currently available.
