Background

The OSCE Project Co-ordinator in Ukraine currently implements Project “Improving Ukraine’s Regulatory System on Chemical Safety and Security” aimed at improving national legislative and regulatory basis on chemical safety and security. New legislation should comply with Ukraine's international obligations, including the Association Agreement between the European Union and Ukraine. The State Emergency Service of Ukraine (SESU) is one of the beneficiaries of the Project, specifically tasked by the Government to develop the legislations on high-risks establishments in line with the EU legal acts in the area of control of major-accident hazards involving dangerous substances – EU Directive 2012/18/EU (SEVESO III). Transposition of SEVESO III Directive into the national legislation has been planned by the end of 2019. The Transposition Plan provides for coordinated involvement of all competent authorities. In order to contribute to the efficient development of the legislations and successful transposition process, the OSCE PCU holds the International consultative workshop on control of major accident hazards involving dangerous substances and on SEVESO III Directive implementation in cooperation with the State Emergency Service of Ukraine and the Major Accident Hazards Bureau (MAHB) of the European Commission Joint Research Centre (EC JRC).

Objective

The aim of the event is to build capacity on control of major accident hazards involving dangerous substances and share experience on transposing SEVESO III Directive into national legislation.
