**STATEMENT BY  
THE DELEGATION OF THE RUSSIAN FEDERATION**

Mr. Chairperson,

The Russian Federation has decided not to interrupt the silence procedure declared by the Spanish Chairmanship in connection with the extension of the contracts for Mr. Markus Müller, Head of the OSCE Centre in Bishkek, and Mr. Gottfried Hanne, Deputy Head of the OSCE Mission to Moldova.

At the same time, we wish to point out the following. This is no less than the second time in the last few months that there has been a deviation from the provisions of the Staff Regulations, specifically paragraphs 3.08 (e) and 3.08 (f), which provide for a limited term of service for staff members in supervisory and other posts at OSCE missions. We take the view that this practice is extremely undesirable, since it lessens the authority of our Organization's regulatory documents. We are assuming that the decision to extend the contracts of Mr. Müller and Mr. Hanne represents an exceptional case and will not have the force of precedence.

I request that this statement be attached to the journal of the day.

## **II. Participation**

The Mediterranean Partners for Co-operation (Algeria, Egypt, Israel, Jordan, Morocco, Tunisia) will participate in and contribute to the Seminar.

The Asian Partners for Co-operation (Afghanistan, Japan, the Republic of Korea, Mongolia and Thailand) will be invited to participate in and contribute to the Seminar.

The OSCE institutions, including the OSCE Parliamentary Assembly, will be invited to participate in and contribute to the Seminar.

## **III. Organizational modalities**

The Seminar will begin at 9.15 a.m. (opening ceremony) on Tuesday, 18 December 2007, and end at 1 p.m. on Wednesday, 19 December 2007.

The opening and closing sessions will be chaired by a representative of the Chairman-in-Office.

Each session will have a moderator and a rapporteur appointed by the Chairperson. The consolidated summary will be forwarded to the Permanent Council for further consideration.

Appropriate arrangements for press coverage will be made.

The working language will be English. At the request of several participating States interpretation will be provided from and into French. These arrangements will not constitute a precedent that can be relied upon in other circumstances.

On the eve of the Seminar, a side event on the role of NGOs in combating intolerance and discrimination and promoting mutual respect and understanding in the OSCE participating States and the Mediterranean Partners for Co-operation, with particular reference to the role of women in promoting tolerance and non-discrimination for Mediterranean NGOs will be held.

Side event(s) will be chaired by a representative of an OSCE participating State or institution.

A report from the side event will be produced and presented by the Chairperson before the start of the first session.

Other rules of procedures and working methods of the OSCE will be applied, *mutatis mutandis*, to the Seminar.

Rooms for additional ad hoc meetings will be made available to participants. Such meetings will be held without interpretation.
