Ireland has enacted national legislation, the *Explosives (Land Mines) Order* (1996) and the *Cluster Munitions and Anti-Personnel Landmines Act* (2008), and taken government decisions to ratify the Convention on Certain Conventional Weapons (in 1981) and its Amended Protocol II (in 1997), The Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction (in 1997), measures which serve to prevent the indiscriminate use of mines, booby-traps and other devices.

As a State Party to the Anti-Personnel Mine Ban Convention, Ireland is subject to the general obligation not to produce or possess anti-personnel mines. Irish Defence Forces Tactical Doctrine has been amended to prohibit the use of anti-personnel mines. The Defence Forces retain a minimal stock for the purposes of training and research in mine clearance techniques, in line with Article 3, paragraph 1 of the Convention. No anti-personnel mine production facilities exist in Ireland.

Irish Defence Forces manuals have furthermore been amended to take account of the technical requirements of the Amended Protocol II to the Convention on Certain Conventional Weapons, and all of the mines retained for training and research purposes conform fully to the technical requirements of Amended Protocol II.

Ireland is committed to victim assistance and believes that such efforts must consist of a nationally led process, with the full and effective participation of survivors and affected communities. We consider that the implementation of the commitments in the 2019 Oslo Action Plan of the Anti-Personnel Landmine Convention will help to ensure a more effective and sustainable approach to victim assistance.

#### 11. Does your country have the capacity to assist others in mine action? If so, please describe.

Yes, the Irish Defence Forces are equipped with a broad range of mine clearance capabilities, including detection systems and mechanical clearance systems. Ireland has been a consistent donor over many years in support of clearance operations related to landmines and unexploded ordnance. Ireland contributed over €4.3 million to humanitarian demining in 2023, providing support intended to benefit the following States: Cambodia, Colombia, Ethiopia, Lao PDR, Somalia, South Sudan, Syria, Vietnam and Zimbabwe. The DF is and has in the past assisted the UN through UNMAS/UNPOL led capacity building programmes, by educating and training local actors and stakeholders in Mine Awareness and Conventional Weapons Disposal (CMD). It deployed two Engineer Corps led training teams to South Sudan in 2013/2014 as part of a capacity building programme to educate and train local police teams in CMD. The DF also has an Engineer Specialist Search & Clearance (ESSC) Team deployed as part of the Irish Group in Camp FAOUR UNDOF. The team regularly conducts search and clearance operations.

In APR- MAY 23 a training team deployed to CYPRUS under EUMAM to instruct UKRAINIAN armed Forces (UAF) in humanitarian demining. A second training deployed from SEP -NOV.

In December 2023 IRELAND donated 2 x Doking MV4 Remote Mine Flails to the UAF.

The DF also has an Engineer Specialist Search & Clearance (ESSC) Team deployed as part of the Irish Group in Camp FAOUR UNDOF. The team regularly conducts search and clearance operations.

In April - May 2023 a training team deployed to Cyprus under EUMAM to instruct UKRAINIAN armed Forces (UAF) in humanitarian demining. A second training deployed from September to November.
