#### DECISION No. 1158 APPROVAL OF THE 2015 UNIFIED BUDGET

The Permanent Council,

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,
- 1. Approves the 2015 Unified Budget contained in Annex I;
- 2. Approves the 2015 Unified Budget Post Table contained in Annex II;
- II. Recalling relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Taking note of the discussions in the framework of the Helsinki+40 process on the efficiency and effectiveness of the budget cycle,

Taking into account Permanent Council Decision No. 705 of 1 December 2005 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the OSCE,

Underlining the importance of the oversight of the OSCE's administrative and financial activities exercised by the participating States, and recalling Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee on Management and Finance (ACMF),

Taking into consideration financial constraints faced currently by the participating States and reiterating that any request for a supplementary budget during a financial year shall be met, wherever reasonable, by reallocating existing resources, and,

Taking note of the report of the Secretary General to the Permanent Council on local staff income taxation, SEC.GAL/122/13 of 28 June 2013, its update, SEC.GAL/136/14 of 28 August 2014, as well as the Chairmanship Conference on Local Staff Income Tax held on 2 September 2014,

- 1. Tasks the ACMF, in co-ordination with the Secretary General, to continue efforts to improve further the programme and budget planning process within the OSCE;
- 2. Undertakes to continue efforts, including throughout the Unified Budget cycle in 2015, to focus, streamline and prioritize the work of the OSCE across the three dimensions in those areas where it has comparative advantage, and tasks the fund managers to ensure the coherence of their programme activities, in accordance with the body of the OSCE principles, commitments and decisions as well as their respective mandates;
- 3. Tasks the Secretary General to explore options for finding further efficiencies in Staff Standard Costs; and tasks the ACMF to discuss these options with a view to optimization during 2015;
- 4. Tasks the ACMF and the Chairmanship, in co-ordination with the Secretary General, to continue discussions for taking practical steps on local staff income tax with a view to achieving full compliance with the OSCE Staff Regulations and Staff Rules;
- 5. Tasks the ACMF to discuss the procurement strategy and process with a view to ensuring respect for openness, transparency and effective competition.

# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"The United States wishes to make the following interpretative statement under paragraph IV.1A(6) of the OSCE Rules of Procedure.

The United States commends the Serbian ACMF Chairperson Ms. Marina Milanovic-Ilic for her leadership of the budget discussions this year.

We have joined consensus today on the 2015 Unified Budget because we believe the Organization must have a budget to move ahead with important programmes and activities to meet its mandates. We believe this budget falls short, however, of adequately addressing the many demands facing the Organization in the coming year.

We are particularly disappointed that the budget does not sufficiently meet the resource needs of the OSCE's three independent institutions: the Office for Democratic Institutions and Human Rights (ODIHR), the High Commissioner on National Minorities (HCNM), and the Representative for Freedom of the Media (RFoM). These institutions, in particular the ODIHR, have been underfunded for years, hampering their ability to implement their mandates to assist participating States to meet their OSCE commitments under the Helsinki Final Act and subsequent agreements. As responsible stewards of the OSCE's financial resources, we must ensure that these institutions receive adequate funding.

Events in and around Ukraine this year have placed tremendous pressure on the resources of the Project Co-ordinator in Ukraine (PCU). We regret that the budget does not provide for additional funding to the PCU above the level proposed in the 2015 budget to allow it to better support the Government of Ukraine's transition towards a democratic, secure, and prosperous future for the country and its people.

We remain concerned with the disproportionate level of the budget that is devoted to field missions in Southeast Europe, and we urge those missions to continue to find cost efficiencies. We would like to see additional funding for field missions in Central Asia to address the security and governance risks and challenges in that region. Again this year, we are disappointed that the Border Management Staff College, the region's only forum for regional border security and co-operation, was excluded from the Unified Budget.

We regret the exclusion from the budget of the UNSCR 1540 programmatic work, which is so critical for the Organization to address the threats of proliferation of weapons of mass destruction and to meet its commitments under the decisions of the Forum for Security Co-operation.

We welcome that this budget begins to correct the shortfall introduced last year by funding two additional positions in the Office of the Special Representative and Co-ordinator for Combating Trafficking in Human Beings.

We continue to call on the Secretariat to seek further efficiencies and greater cost containment, particularly related to Staff Standard Costs, and to focus the Secretariat's resources on programmatic activities.

The OSCE today is very different from the OSCE of a year ago, as demonstrated by the Organization's response to the crisis in European security that has manifested itself in and around Ukraine. We call on participating States to take a renewed look at the unique role of the Organization and to ensure that it is well resourced to carry out its mandate across all three dimensions of comprehensive security.

The United States requests that this statement be attached to the decision and recorded in the journal of the day.

By the delegation of Azerbaijan:

"While joining the consensus on the Permanent Council decision on approval of the 2015 Unified Budget, the Delegation of the Republic of Azerbaijan would like to make an interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the OSCE.

'It has been our longstanding concern that significant resources allocated through the Unified Budget to the OSCE Office in Yerevan, have been used to provide technical support and equipment to Armenia, not least by means of the activities of Office in the politico-military dimension. Office's continued efforts aimed at upgrading capacities of the Armenian Humanitarian Demining Centre are an example in this regard.

We joined consensus on 2015 Unified Budget decision on the understanding that the OSCE, especially the Office in Yerevan, will keep an oversight of these activities and ensure that technical assistance and equipment provided to Armenia in the area of demining will not be used in the occupied territories of the Republic of Azerbaijan.'

We request that this statement be attached to the decision adopted and be included to the journal of the day."

# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Italy on behalf of the European Union:

"The Member States of the European Union thank the incoming Serbian Chairmanship for its fruitful efforts and professionalism to make possible the adoption of the 2015 OSCE Unified Budget in good time in accordance with the provisions of the decisions on the budget cycle.

This budget nevertheless presents a number of recurrent difficulties.

- The slight increase in the allocation to the Office for Democratic Institutions and Human Rights does not reflect the current issues and challenges. It is by no means satisfactory. The Office in Warsaw cannot continue in particular to work with unchanged resources for election monitoring, which jeopardizes the full accomplishment of its mandate in this area. We shall ensure that this situation is rectified next year.
- The budget for the OSCE Representative on Freedom of the Media and the High Commissioner on National Minorities is also a cause for concern. A larger allocation should be allowed for these two institutions. We regret that, as every year, some countries continue to object in spite of the fact that the amount at stake is small.
- The budgets for the missions in Central Asia are still too small and do not reflect the security challenges encountered in this region. The slight increase is not adequate in particular for Tajikistan, where the OSCE Border Staff Management College in Dushanbe is now faced by an uncertain financial situation because of its non-inclusion in the Unified Budget.
- Finally, certain cross-cutting issues continue to weaken the OSCE budget in the long term. In particular, the salary costs are not being sufficiently contained, and the Secretariat has not made an adequate proposal to remedy the situation. This has a negative impact on the Organization's regular operations.

At the same time, we should like to welcome some positive developments.

- Within the Secretariat, the Conflict Prevention Centre will be provided with additional personnel to deal with the crisis in Ukraine. It will also have a significant allocation for crisis management.
- Moreover, the economy measures undertaken by the field missions in south-eastern Europe thanks to the important reorganization efforts are bearing fruit, enabling a reallocation of these funds to other executive structures.

Finally, the discussion on the 2015 Budget this year once again demonstrated the need to find a solution to the matter of the augmentation fund in the 2016 budget cycle in compliance with the commitments made by the participating States regarding their scale of contributions."

# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of France (also on behalf of Spain and the United Kingdom):

"This statement is made on behalf of France, Spain and the United Kingdom.

We thank the incoming Serbian Chairmanship for its untiring efforts and skill to enable the OSCE Unified Budget for 2015 to be adopted in accordance with the provisions of the decisions on the budget cycle.

We fully endorse the statement made by the delegation of Italy on behalf of the Member States of the European Union and would like to point out that as individual countries we were only able to join the consensus on the following terms:

- The 2015 Unified Budget contains a special "augmentation fund", which has no legal basis. Decision No. 827 adopted by the Permanent Council in 2007 clearly stated that it was established on a provisional basis and that it was linked to the budget for the 2008 financial year.
- The continuation of this practice, which consists of invoicing part of the Secretariat's
  personnel costs according to the scale of contributions for field operations, cannot
  thus be regarded as having a legal basis.
- Its continuation was tolerated in order to facilitate consensus.
- As a result of this practice, 65.5 posts based in the Secretariat will continue to be indexed in the 2015 Unified Budget according to the scale for field operations, which means that 11 participating States are having to pay a larger contribution than they should have done according to the financial commitments detailed in Permanent Council Decision No. 1072.

So as not to delay the adoption of the OSCE Budget, France, Spain and the United Kingdom have agreed not to contest the continuation of this practice this year, despite the fact that it is contrary to the financial regulations.

We should like to inform the Permanent Council that under no circumstances will this agreement apply to future financial years and that we shall not be in a position to accept the inclusion of a fund of this type in future Unified Budgets.

France, Spain and the United Kingdom request the Secretariat to bear this in mind when preparing the 2016 Unified Budget proposal and to comply strictly with the relevant decisions adopted here.

I request that this statement be attached to the decision."
