AMBASSADOR YUSUF BULUÇ, IN RESPONSE TO
H.E. BENITA FERRERO-WALDNER,
EUROPEAN COMMMISSIONER FOR EXTERNAL RELATIONS AND ENP

699TH MEETING OF THE PERMANENT COUNCIL 31 JANUARY 2008

We warmly welcome the distinguished Commissioner in our midst. Her appearance

before the Permanent Council, coming on the heels of H.E Dr.Rupel's address to the Council

last week, represents and confirms the mutually felt necessity of intensified communication

and close cooperation between the EU and the OSCE. Today, this cooperation is of crucial

significance as, in view of a few issues facing our community, failing to do so will carry

equally significant penalties.

While I shall do my utmost not to repeat the elements of my address to Minister

Rupel, the theme of ENP is one that is worth being repetitive. The initiatives undertaken

within the European Neighborhood Policy and the enlargement strategy demonstrate not only

the gravitational pull of the European Union but also the will for a pro-active engagement on

the EU side with the candidates and neighbours alike, with a view to addressing the increasing

uncertainties in its periphery.

Turkey, both within and beyond the commitments and responsibilities derived from its

accession relationship with the European Union, has a high stake in the search to attain

enhanced security, stability and prosperity in its region. We share the future as well as the

underlying challenges with the countries that the EU has so wisely established contractual

relationships through action plans and some other policy devices. Challenges such as

terrorism, organized crime, trafficking in human beings, corruption, discrimination, and

policies which curtail the enjoyment of democracy by the peoples.

South Caucasus sadly hosts three of the four so-called frozen conflicts in Europe. The

success or failure in reaching peaceful and lasting solutions to these protracted conflicts will

have repercussions well beyond the region. Likewise, intensified relations with the states of

Central Asia will offer a multitude of new opportunities. EU, through its encouraging opening

towards its neighbours, has contributed to the emergence of promising perspectives in this

region.

The risks posed to the stability and security in the Balkans are high on the agenda of

the EU and the OSCE. It should be recalled that existing stabilizing compromises have been

accomplished through hard work and skilful diplomacy. The OSCE as well as the EU have

huge responsibilities in addressing the legitimate European aspirations of the Balkan people

while promoting peaceful co-existence of multi-ethnic societies.
