> Interpretative statement under paragraph 79 (Chapter 6) of the Final Recommendations of the Helsinki Consultations

By the Delegation of Ukraine:

"Taking into account that the organizations, institutions and initiatives that are to be invited to the Eighth Meeting of the OSCE Ministerial Council according to the PC decision just taken also include the Commonwealth of Independent States, the Delegation of Ukraine has been instructed to make the following interpretative statement.

The Ukrainian delegation has already informed you and other delegations that we have objections to the provisions of the document relating to the list of international organizations, institutions and initiatives that it is planned to invite to attend the ministerial meeting.

We consider that there are no reasons to include in this list the Commonwealth of Independent States.

There are several arguments in this connection. First of all, the Commonwealth of Independent States will be represented at the meeting individually by foreign ministers, and all other delegations will have a chance to hear the positions of the CIS countries on the issues discussed.

Second, Madam Chairperson, the CIS has only one standing body - the so-called Executive Committee. And, as we understand it, the invitation will be sent to that Committee. However, the Executive Committee has no right to speak on behalf of the CIS participating States or to deal with international security issues without a specific decision of the CIS top bodies, for example, its Council of Presidents or Council of Ministers, which, if they so decide, could elaborate a common position on a given issue. We are not aware that any such decision has been taken by either of these bodies.

Moreover, experience gained from the previous participation of the Executive Committee in high-level OSCE events demonstrates that its written contributions have never reflected the relevant position of each and every CIS participating State.

At the same time, being fully aware of the need for the Chairmanship to proceed with the preparations for the Ministerial Council, we have agreed to include in the decision the "Commonwealth of Independent States". In this connection, it is our understanding that the CIS Executive Committee will be invited to make a written contribution on behalf of itself or any other CIS participating State, but not on behalf of Ukraine."
