STATEMENT BY THE DELEGATION OF KAZAKHSTAN

Thank you, Mr. Chairperson,

I am taking the floor to make just a few remarks regarding the deliberations on the draft decision on Kazakhstan's Chairmanship in the Organization in 2009 that took place at the Preparatory Committee meeting on 28 November.

First, we are grateful to the Chairmanship for including this issue on the agenda, strictly in line with the Rules of Procedure.

Of course, we wish to reiterate our gratitude to the colleagues who, on behalf of their delegations, have firmly confirmed their endorsement of our application.

Nevertheless, the Chairmanship's refusal to circulate the draft, which, according to the above-mentioned Rules, would be a normal duty of any Chairmanship, on the pretext of an absence of consensus on its content, is an alarming sign of the situation in the OSCE.

I am sure you will agree that among the Ministerial Council draft decisions, there are a number that may be considered to be of the similar status, in other words, lack consensus. All of them deserve a normal form of draft decisions.

In this situation, we proceeded on our own, strictly following the Rules of Procedure and the provisions of Ministerial Council Decision No. 8 adopted at Porto, and in accordance with previous experience.

Mr. Chairperson,

Kazakhstan will continue to promote its legitimate right to contribute to the future of this Organization in 2009 as Chairman. This is our firm political will, and we see no reason to step aside. We do not challenge the moral authority of any of our partners to share their expertise with others. Nevertheless, this has nothing to do with the issue of the Chairmanship itself. The pretence of imposing additional criteria is a clear violation of the principle of the equality of the participating States in this Organization. Instead, it would be logical to discuss these criteria as regards the issue of membership itself. However, once it has become a part of the Organization, every individual State may contribute its specific talents and expertise on an equal footing.

We confirm once more our readiness to pursue an open dialogue with all the interested parties in the search for a wording that can attract a consensus. That consensus should be based on the principles outlined earlier.

I ask you, Mr. Chairperson, to include this statement in the journal of this meeting.
