Belgrade, 26 - 27 March 2015

The Chairmanship-in-Office presents its compliments to all OSCE Delegations and participants and has the honour to inform them about the following organizational modalities for the conference on the Protection of safety and integrity of journalists in the OSCE region, to be held in Belgrade on 26-27 March 2015.

LOGISTICAL MODALITIES

1. VENUE	Palace "Serbia" 2 Mihaila Pupina Blvd, Conference Room "Srbija" Belgrade, Serbia
2. PARTICIPANTS	Representatives from the OSCE participating States, OSCE Partners for Co-operation, OSCE institutions and field presences, representatives of governments and international organizations, media, legislators, academia and NGOs will participate at the Conference. No fee for participation is requested.
3. WORKING MODUS OF THE CONFERENCE	The Serbia's OSCE Chairmanship, with the support of the Representative on Freedom of the Media, is organising a conference on the Protection of safety and integrity of journalists in the OSCE region, on 26 and 27 March 2015 in Belgrade. The purpose of the Conference is to examine and review the current situation relating to the safety of journalists, to share the problems and best practices, to determine the principal requirements for reforming relevant legislation, law-enforcement practices, and judicial instruments, and to initiate the formulation of recommendations to the governments on ways of improving the security of journalists in the OSCE area. The Conference will focus on the following four parallel sessions: - Safety of journalists after Charlie Hebdo: challenges of violent attacks on the media; - Safety of female journalists online - Digital security and internet literacy for media and journalists - Legal protection and integrity of journalists

5. REGISTRATION AT THE CONFERENCE	26 March, 2015 from 9.00 – 9.30 We kindly ask participants to arrive at the Conference venue till 9.00 to allow time needed for registration.

MEDIA	Representative of foreign media (editor, journalist, photo-reporter, cameraman and other collaborators) should send the request for acquiring press card via herby enclosed Form1, as well as enclosing following: 1. The cover letter of the responsible person of the foreign media whose representative he/she is and 2. photocopy of passport or identity card Representatives of foreign media who already have the appropriate press card issued by the Ministry of Culture and Information, and representatives of the local media, apply by sending a number of their press card, in order to form the list and regulate entry to the Palace of Serbia. All applications should be submitted via the email address ana.skocic@kultura.gov.rs, no later than 20 March 2015.
