**STATEMENT BY THE DELEGATION OF CANADA**

Thank you Mr. Chairman,

On 22 November 2004, the Canadian Arms Control Verification Unit sent a Format 33 inspection request to the Uzbekistan Verification Unit, in accordance with the Vienna Document 99. The Canadian inspection request was declined by the Uzbekistan Verification Unit invoking “force majeure” under Section IX, article 78.1. No further information was provided on the cause or to specify the period of time covered, as required by the Vienna Document.

This latest refusal was the third instance that our Verification Unit saw their inspection request declined by Uzbekistan stating “force majeure” but without any further explanation. According to Article 78.2 of the Vienna Document, the Receiving State should, without delay, contact the Requesting State to provide an explanation of the circumstances of this “force majeure” giving also an approximate duration of this situation. Our efforts to date to communicate with Uzbekistan through diplomatic channels to obtain more information have unfortunately been unsuccessful.

We continue to look forward to receiving such information from Uzbekistan’s Verification Unit, and will be pleased to discuss further this issue with Uzbekistan in a co-operative manner.
