STATEMENT BY THE CHAIRPERSON OF THE INFORMAL GROUP OF FRIENDS ON SMALL ARMS AND LIGHT WEAPONS AND STOCKPILES OF CONVENTIONAL AMMUNITION (LATVIA)

Your Excellencies, Dear colleagues,

I should like to make a few remarks in my capacity as the Chairperson of the Informal Group of Friends on Small Arms and Light Weapons (SALW) and Stockpiles of Conventional Ammunition (SCA).

First of all, I wish to commend the speakers for highlighting the wider contribution that OSCE practical assistance projects in the field of SALW and SCA make towards the achievement of common intended outcomes related to the enhancement of security and safety in the OSCE area. Cross- dimensional fertilization in co-ordinating and implementing practical measures on SALW and SCA is obvious. Further synergies could perhaps be achieved by focusing on shared norms and principles that are relevant to the OSCE's concept of comprehensive, co-operative, equal and indivisible security.

Dear colleagues,

I am pleased to provide you with some feedback on the Meeting on Reviewing and Updating the OSCE Best Practice Guides on Small Arms and Light Weapons and Conventional Ammunition", which was held in Vienna on 7 October 2019. The meeting was attended by 54 participants from 23 participating States and the OSCE Conflict Prevention Centre, including subject-matter experts sent by their governments and delegates based in Vienna. It helped in further raising awareness of the OSCE Best Practice Guides (BPGs) on SALW and SCA and in refining the process for updating them. I have already shared with you, esteemed colleagues, my perception paper summarizing the discussions that took place at the meeting and its outcomes (document FSC.DEL/228/19 of 29 October 2019). This perception paper will serve as the basis for a future food-for-thought paper that will guide the OSCE's next steps in updating the BPGs on SALW and SCA. Dear colleagues,
